

RESOLUTION No. 223713 (R-79-2419)


Adopted on JUN 18 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the low bids of a. FAMILIAN PIPE AND SUPPLY, and b. SAN DIEGO PIPE AND SUPPLY, are hereby accepted; and the City Manager is hereby authorized to execute contracts for the purchase of PIPE, FITTINGS AND MISCELLANEOUS PLUMBING SUPPLIES as may be required for a period of one (1) year beginning July 1, 1979 through June 30, 1980 per prices on file in the Purchasing Department as follows:

- a. FAMILIAN PIPE AND SUPPLY; for Sections I, II, III and IV; terms 2% 30 days, plus sales tax and two (2) price increases during the contract year, each increase not to exceed $7\frac{1}{2}\%$ of bid price with an option to renew for an additional one (1) year period at bid prices subject to an additional 12% escalation.
- b. SAN DIEGO PIPE AND SUPPLY; for Section V; terms 2% 10th prox., plus sales tax and two (2) price increases during the contract year, each increase not to exceed 10% of the bid price, with an option to renew for an additional one (1) year period at bid prices subject to an additional 30% escalation.
