Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "ARBOR CANYON VIEW ESTATES Being a subdivision of Lots 1 to 24 inclusive in Block 13 of Arnold and Choates Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 334, filed in the office of the County Recorder of San Diego County, November 29, 1872, of which a portion of Lot 13 is also a portion of Arbor Drive dedicated to public use.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
