BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by DON NASLAND, a Licensed Land Surveyor, entitled "BOARDWALK LA JOLLA Being a subdivision of Parcel 1 of Parcel Map 5597, in the City of San Diego, County of San Diego, State of California, according to Map thereof on file in the office of the County recorder of San Diego County, being Parcel 2 of Parcel Map No. 5323, filed in the office of the County Recorder of San Diego County, and as corrected by Certificate of Correction, recorded November 16, 1977, Recorder's File No. 77-474591 and 88-474592 of Official Records.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.
