BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of ARTURO and KAIJA MARCON, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date of April 24, 1979, conveying to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair a public street, over, under, along and across all that portion of Lot 12, Block 8 of SUNNY SLOPE ADDITION TO ENCANTO HEIGHTS, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 69TH STREET.

That the City Clerk of said City is hereby authorized and directed to deliver said deed, and a certified copy of this resolution to the Engineering and Development Department for further handling.
