

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of JERRY J. MITCHELL, KATHERINE P. MITCHELL, WILLIAM A. ROBINSON, ELAINE L. ROBINSON, ROGER D. GREGG, WYNETTE C. GREGG, MICHAEL L. ROBERTS, and MARCELLA ANN ROBERTS, executed in favor of The City of San Diego, bearing date of April 24, 1979, conveying to said City a permanent easement and right-of-way for a public street, and incidents thereto, over, under, upon, along and across all that portion of Lots 24 and 25 of Del Sur No. 1, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 65TH STREET.

That the City Clerk be, and he is hereby authorized and directed to deliver said deed, and a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
