WHEREAS, the aforementioned sewer easement has never been used for the purpose for which it was originally acquired; and


WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
