

RESOLUTION NO. 223738

WHEREAS, the "Mira Mesa Golden Friends Corporation" and "The North County Philipino American Services" desire to have a senior citizens building constructed in Mira Mesa Community Park; and

WHEREAS, no City funds are currently available for the construction of a senior citizens building in Mira Mesa Community Park; and

WHEREAS, the "Mira Mesa Golden Friends Corporation" and "The North County Philipino American Services" desire to obtain federal funds to construct a senior citizens building; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the concept of the use of a 320-foot by 240-foot area in the south central portion of Mira Mesa Community Park, for a Senior Citizens Recreational Building and other related facilities to be funded, developed and operated by the "Mira Mesa Golden Friends Corporation" and/or the "North County Philipino American Services," is hereby approved subject to the following conditions:

1. Total financing of the development, operation and interior maintenance of the senior citizens facilities shall be borne by the private groups cited above, and the project shall be in accordance with Council Policy 700-7, except that the only City contribution to the project shall consist of

allowing the use of the park land for the location of the facilities, and maintenance on the building's structure is to be provided by the Buildings Division of the General Services Department.


2. The size of the proposed facility shall not exceed approximately 4,000 square feet in floor area.

3. The facilities are to be open to all senior citizens, without restrictions, and that scheduling of those facilities is to be monitored by City staff.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to negotiate an agreement with the organizations cited above for the use of a portion of Mira Mesa Community Park; this agreement will be subject to the above conditions and will be executed only upon Council approval.
