
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to apply for and execute a grant agreement, and any reasonable modifications thereof, with the CALTRANS Division of Aeronautics to resurface the Montgomery Field runways, taxiways and transient aircraft parking ramp with asphaltic emulsion slurry seal, said application is on file in the office of the City Clerk as Document No. '766584.

BE IT FURTHER RESOLVED, that it is hereby certified that matching funds are available to meet the required local share to the project cost in the fiscal year for which the application is made; and that Montgomery Field meets the eligibility requirements set forth in Article 2 of CALTRANS Division of Aeronautics, September, 1977 Guide to the California Aid to Airports Program.

BE IT FURTHER RESOLVED, that the expenditure of \$12,500 be hereby authorized out of General Fund 100 (Airport Division) of The City of San Diego, solely and exclusively, for the above described project.
