WHEREAS, information has been received by the City Council to the effect that dredging operations within the San Pasqual Valley area by City lessees have created a situation whereby City property may be significantly damaged if such dredging continues in its present manner; and


WHEREAS, the City seeks to avoid any such potential significant damage in the interest of the public health, safety and general welfare and specifically in the interest of avoiding any undue waste of City resources; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager and the City Attorney are hereby authorized and directed to prepare and deliver an appropriate notice to lessees in the San Pasqual Valley area to temporarily cease and desist from conducting any dredging operations.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to conduct an analysis of the sand-mining operations to determine the impact on the bridges, roads, all leased lands and the river itself, including the silting of Lake Hodges, and to determine the extent of loss of City resources.
