

RESOLUTION No. 223769 (R-79-2418)


Adopted on JUN 22 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of BASILIO A. FREITAS and RACHEL MOORE FREITAS, joint tenants, executed in favor of The City of San Diego, bearing date of November 29, 1978, conveying to said City an easement for public street purposes over, along and across all that portion of Lot 12 of M.L., King Park Unit No. 1, Map No. 8010, and all that portion of Lot G of Encanto, Map No. 749, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Lot G of Encanto, Map No. 749, is hereby dedicated as and for a public street and the same is hereby named HENSON STREET.

That the City Clerk be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
