

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one warrant check in the amount of \$24,500.00 made payable to Eva Bredfield and her attorney Richard F. Gerry, in full settlement of the lawsuit and of all claims.
