BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$108,730.00 by WAL-CON CONSTRUCTION & JOHN M. ARTUKOVICH (J.V.), a joint venture, for REPAIR AND MODIFICATION OF ODOR REMOVAL TOWER NO. 4 AT THE PT. LOMA WASTEWATER TREATMENT PLANT, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765905.
2. That the City Auditor and Comptroller is hereby authorized to transfer within the Sewer Revenue Fund 506, \$140,700.00 from the unallocated reserve (69.97) to Point Loma Treatment Plant Maintenance (62.35).
3. That the expenditure of \$140,700.00 from Sewer Revenue Fund 506, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
