

RESOLUTION No. 223778 (R-79-2490)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of (1) JACK'S TRACTOR & EQUIPMENT, INC. (2) MISSION FORD TRACTORS, INC. (3) INTERNATIONAL HARVESTER CO. (4) CASE POWER & EQUIPMENT and (5) B. HAYMAN CO., INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LIGHT, MEDIUM AND HEAVY DUTY TRACTORS as follows:

(1) JACK'S TRACTOR & EQUIPMENT, INC. for ITEM 1 - ONE (1) TRACTOR BACKHOE (Massey Ferguson Model 60) at a cost of \$29,500.00; terms net 30 days, plus sales tax.

(2) MISSION FORD TRACTORS, INC. for ITEM 2 - ONE (1) TRACTOR BACKHOE (Ford Model 555) at a cost of \$24,400.00; terms net 30 days, plus sales tax, less trade-in allowance of \$5,000.00 for one (1) tractor backhoe.

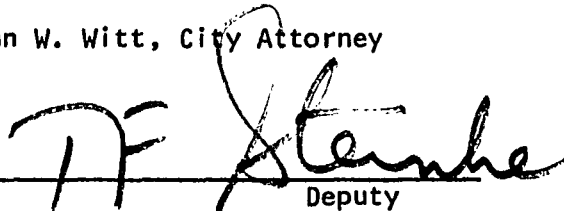
(3) INTERNATIONAL HARVESTER CO. for ITEM 3 - ONE (1) TURF TRACTOR (International Model 238) at a cost of \$7,437.00; terms net 30 days, plus sales tax.

(4) CASE POWER & EQUIPMENT for ITEM 4 - ONE (1) TRACTOR LOADER/BACKHOE (Case Model W14) at a cost of \$35,089.00; terms net 30 days, plus sales tax, less trade-in allowance of \$6,000.00 for a used loader/backhoe; ITEM 6 - FIVE (5) TRACTOR LOADER/BACKHOES at a cost of \$27,352.00 each for a total cost of \$136,760.00; terms net 30 days, plus sales tax, less trade-in allowances of used equipment as follows: Truck mounted backhoe for \$2,200.00, tractor loader/scrapper for \$1,500.00, tractor loader for \$1,800.00; ITEM 7 - SIX (6) TRACTOR LOADERS (Case Model 480C) at a cost of \$14,480.00 each for a total cost of \$86,880.00; terms net 30 days, plus sales tax, less trade-in allowances as follows: four (4) tractor loaders for \$3,000.00 each for a total cost of \$12,000.00 and one (1) tractor for \$1,800.00; ITEM 8 - SIX (6) TRACTOR LOADERS (Case Model 380LL) at a cost of \$11,482.00 each for a total cost of \$68,892.00; terms net 30 days, plus sales tax, less trade-in allowances as follows: One (1) tractor-dozer for \$2,200.00, one (1) tractor-loader for \$1,800.00 and four (4) tractors at \$1,200.00 each for a total cost of \$4,800.00; ITEM 9 - ONE (1) TRACTOR LOADER (Case Model 480C) at a cost of \$15,635.00; terms net 30 days, plus sales tax, less trade-in allowance of \$1,200.00 for one (1) tractor loader.
