BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bids of a. SYNER GRAPHICS INC., and b. 3M BUSINESS PRODUCTS SALES INC., are hereby accepted; and the City Manager is hereby authorized to execute contracts for MICROFICHE READER/PRINTERS AND MICROFICHE READERS as follows:
  - a. SYNER GRAPHICS INC.; for the purchase of FIFTY (50) EACH MICROFICHE READERS for a cost of \$130.75 each, for a total cost of \$6,537.50; terms net 30 days, plus sales tax.
  - b. 3M BUSINESS PRODUCTS SALES INC.; for the purchase of FOURTEEN (14) EACH MICROFICHE READER/PRINTERS for a cost of \$1,483.20 each, for a total cost of \$20,764.80; terms net 30 days, plus sales tax.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$32,000.00 from the General Fund Unallocated Reserve to the General Fund, Fund 100, Department 5331, for the purchase of Microfiche Reader/Printers and Microfiche Readers and initial support supplies.


