APPROVING MAP OF CAMBRIDGE COLONY UNIT NO. 1
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE
MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by
ROY G. ANDERSEN, a Registered Civil Engineer, entitled "CAMBRIDGE
COLONY UNIT NO. 1 Being a subdivision of portions of Pueblo
Lots 1204, 1205 and 1212 of the Pueblo Lands of San Diego in
the City of San Diego, County of San Diego, State of California
according to the Map thereof made by James Pascoe in May 1870, a
copy of which has been filed in the San Diego County Recorder's
Office and is known as Miscellaneous Map No. 36, together with
Genesee Avenue as dedicated to public use.," is made in the manner
and form prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is hereby
approved and accepted; and said Council hereby accepts on behalf
of the public, the following: Acworth Avenue, Mt. Aclare Avenue,
Mt. Acomita Avenue, Aloe Avenue, Alp Street, Mt. Alvarez Avenue,
Java Street, Boyd Avenue, Amboy Avenue, Mt. Albertine Avenue,
Thornwood Street, and the alley for public purposes; and
said streets and alley are hereby declared to be public
streets and a public alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, any
and all abutters' rights of access in and to Mt. Alvarez Avenue,

adjacent and contiguous to Lots 91, 92, and 93; and in and to Accomac Avenue, adjacent and contiguous to Lot 52, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved this subdivision map and that said public streets and public alley are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, as well as the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdividers, ROY G. ANDERSEN and NANCY R. ANDERSEN, that said subdividers will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of CAMBRIDGE COLONY UNIT NO. 1.
