

RESOLUTION NO. 223796 (R.79-2505)

WHEREAS, with the approval of the final map of CAMBRIDGE COLONY UNIT NO. 1 subdivision, the City shall receive easement interests which allow the quitclaim of existing sewer, drainage and slope easements within the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. 766656, quitclaiming to ROY G. and NANCY R. ANDERSEN, husband and wife, all the City's right, title and interest in the sewer, drainage and slope easements, as more particularly described in said quitclaim deed.
