Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "TERRACE GREEN UNIT NO. 2 Being a subdivision of Lots 1025, 1026 and 1027 of Bay Terraces Unit No. 14, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7764, filed in the office of the County Recorder of San Diego County, October 16, 1973.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for general utility purposes over, under, upon and across Lots 5, 6, 7 and 8, as granted and shown on said map and subject to the conditions set forth thereon.


