

RESOLUTION OF INTENTION NO. 223801 (R. 79-2324)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS **JUN 25 1979**
OF THE STREET VACATION ACT OF 1941, DECLARING THE
INTENTION OF THE CITY COUNCIL TO VACATE LA AMATISTA
BETWEEN MANGO DRIVE AND MIRA MONTANA DRIVE, AND FIXING
A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San
Diego, that the public interest and convenience of said City
require the vacation of La Amatista between Mango Drive and
Mira Montana Drive; and

BE IT FURTHER RESOLVED, that it is the intention of said
Council to order the vacation of La Amatista between Mango Drive
and Mira Montana Drive, as more particularly shown on Drawing
No. 14580-B on file in the office of the City Clerk as
Document No. 766635.

The Council hereby fixes 2:00 P.M. JUL 31 1979 in
the Council Chambers on the twelfth floor of the City Administration
Building, Charles C. Dail Concourse, 202 "C" Street, in said
City of San Diego, as the time and place for hearing all persons
interested in or objecting to the proposed vacation.


That The Daily Transcript, a daily newspaper published
