A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THE SOUTHERLY 100 FEET OF THIRTY-FIRST STREET BETWEEN REDWOOD AND THORN STREETS AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of the Southerly 100 feet of Thirty-first Street between Redwood and Thorn Streets, as more particularly shown on Drawing No. 14629-B on file in the office of the City Clerk as Document No.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 P.M. JUL 311979 the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
