BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an agreement with Atkinson, Johnson and Spurrier, Inc. to provide professional engineering services in connection with the design of the Vermont Street Pedestrian Bridge.

2. That the Vermont Street Pedestrian Bridge, CIP No. 54-003 be placed in the FY 79 CIP program.

3. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$50,025 from the Capital Outlay Unallocated Reserve Fund #90-245 to the 245 Fund of CIP No. 54-003, for the purpose of providing funds for professional engineering services in connection with the design of the Vermont Street Pedestrian Bridge.

4. That the expenditure of \$50,025 is hereby authorized out of 245 Fund of CIP No. 54-003, solely and exclusively for the purpose of providing funds for professional engineering services in connection with the design of the Vermont Street Pedestrian Bridge.


