RATED CAPACITY OF ONE TON OR MORE:

ACENA DRIVE between Rancho Bernardo Road
and Lomica Drive.

BE IT FURTHER RESOLVED, that the installation of the
necessary signs and markings be, and they are hereby authorized
to be made on said street.

BE IT FURTHER RESOLVED, that the regulations hereinabove
imposed shall become effective upon the installation of such
signs.
