

RESOLUTION NO. 223808

WHEREAS, on September 12, 1978, the Council authorized, by Resolution Nos. 765100 and 765102, an application to the State of California for a grant under the Land and Water Conservation Fund Program for the acquisition of approximately 374 acres of privately-owned land to be included in the Lake Murray-Cowles-Fortuna Mountain Regional Park, and for the development of a portion of approximately 18 acres of the City-owned Tierrasanta Community Park site; and

WHEREAS, on December 29, 1978, the State of California notified the City that a Memorandum of Understanding with the State Historic Preservation Officer is necessary to comply with Executive Order 11593 and the National Historic Preservation Act, prior to final State funding authorization of the two grants; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute a Memorandum of Understanding with the State Historic Preservation Officer as part of the City's grant application for Land and Water Conservation Fund assistance in the development of Tierrasanta Community Park and the acquisition of a portion of Lake Murray-Cowles-Fortuna Mountain Regional Park, said Memorandum of Understanding is on file in the office of the City Clerk as Document No. 766754.
