WHEREAS, it is proposed that the Planning Director be authorized to establish fees and deposits to recover costs involved with review and processing of environmental documents by the Planning Department; and

WHEREAS, these fees and deposits would be based on recovery of City costs in preparing and reviewing environmental documents, including personal services, related nonpersonal expenses, and standard City overhead rates; and

WHEREAS, the fees and deposits will recover City costs involved with the issuance of environmental documents itemized in the City book of fees and charges on file in the office of the City Clerk; and

WHEREAS, the fees and deposits will incorporate the user-fee principal, and it is the desire of the City to recover only those costs incurred; and

WHEREAS, it is requested that the Planning Director be authorized to update these fees as necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Director is hereby authorized to establish fees and deposits for said Planning Department environmental services in order to recover costs incurred in accordance with the "Planning Department Fee Schedule" on file in the office of the City Clerk as Document No. 765559.
