BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$486,000.00 by IT CORPORATION, a corporation, for CLEANING OF DIGESTER N-1-P AT THE POINT LOMA WASTEWATER TREATMENT PLANT, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 766230.
2. That the City Auditor and Comptroller is hereby authorized to cancel CIP-No. 46-033, Metropolitan Pump Station No. 1, Odor Control Facilities.
3. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$300,000.00 within Sewer Revenue Fund 506 from CIP No. 46-033 (63.92) to Point Loma Treatment Plant Maintenance (62.35).
4. That the expenditure of \$300,000.00 from Sewer Revenue Fund 506, to supplement Resolution No. 223481, of the City of San Diego, is hereby authorized solely and exclusively for providing funds for said project.
