BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$375,193.00 by ACME PIPELINE AND COMPANY, a partnership, for CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 407 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 766002.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$123,807.00 within the Water Revenue Fund 502 from In-Lieu Tax Payments (63.17) to Water Construction Outlay (66.92).
3. That the expenditure of \$506,000.00 from Water Revenue Fund 502 and \$71,000.00 from Sewer Revenue Fund 506 of the City of San Diego solely and exclusively for providing funds for said project and related costs.


