2. That the City Auditor and Comptroller is hereby authorized to transfer \$733,000.00 within Sewer Revenue Fund 506 from the Unallocated Reserve (69.97) to Water Construction Outlay (64.92).
3. That the expenditure of \$733,000.00 is hereby authorized from Sewer Revenue Fund 506 to supplement Resolution No. 223564.
