


RESOLUTION No. 223827 (R-79-2587)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$277,315.10 by LONG, MARKER & HOWLEY CONSTRUCTION CO., a corporation, for the CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 413 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 766315.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$44,000.00 within Water Revenue Fund 502 from In-Lieu Tax Payments (63.17) to Water Construction Outlay (66.92).
3. That the expenditure of \$44,000.00 is hereby authorized out of Water Revenue Fund 502 to supplement Resolution No. 223526.
