

RESOLUTION NO. 223845

(R. 79-2494)

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$20,000 in Revenue Sharing Social Service Savings, 267 Fund, and \$73,333 in Revenue Sharing Social Service funds from the Fiscal Year 1980 Housing and Community Services Department, 2390 Fund, to the Park and Recreation Department Special Fund for the 1979 Summer Recreation Support Program, contingent upon approval of the Fiscal Year 1980 Appropriation Ordinance.

2. That a total expenditure of \$119,486 from Recreation Support Program Special Fund 2653 by the Park and Recreation Department (Recreation Division) be hereby authorized, contingent upon approval of Fiscal Year 1980 Appropriation Ordinance, in the amounts and for the purposes stated below:

\$30,819	Administering the Recreation Support Program
76,467	Conducting the 1979 Recreation Support Program
7,000	Conducting Recreation Support Program activities
5,200	Disbursing to agencies if needed to compensate for possible increases in transportation costs due to the rising cost of gasoline.
