GARDENS; and

WHEREAS, the present development of the property requires  
realignment of the existing drainage easement; and

WHEREAS, this aforementioned drainage easement no longer  
serves the purpose for which it was originally acquired; and

WHEREAS, the City will receive substitute easements where  
required as granted on the map of the subdivision known as  
COLLEGE PARK GARDENS; and

WHEREAS, the City has no present or prospective use for  
said easement and the City Manager has recommended that the  
City abandon its interests therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego,  
as follows:


1. That the City of San Diego by this resolution does

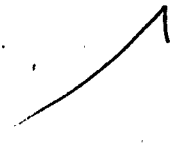
