APPROVING MAP OF MEADOW RUN UNIT NO. 3 SUBDIVISION
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "MEADOW RUN UNIT NO. 3 Being a subdivision of Lot 1018 of Bay Terraces Unit No. 10, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7052, filed in the office of County Recorder of San Diego County on September 15, 1971.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Pembridge Lane, Pennington Lane, Crosshaven Lane, Attleborough Court, Tenbury Court, Beckington Lane and Beckington Way for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Tooma Street, Adjacent and contiguous to Lots 225 through 248 inclusive, in and to Casey Street, adjacent and contiguous to Lots 248 through 269 inclusive, in and to Wattle Drive, adjacent and contiguous to Lots 201, 202, 203, 204, 205, 269, 270, 271 and 272, and in and to Tenbury Court, adjacent and contiguous to Lots 273

and 274, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, all as shown on this map within this subdivision.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider TREETOPS UNLIMITED that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MEADOW RUN UNIT NO. 3.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
