as follows:

That the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for BAY TERRACES UNIT NO. 14, on file in the office of the City Clerk as Document No. 745106, to provide for the substitution of TREETOPS UNLIMITED, a joint venture, for SOUTHERN CALIFORNIA TERRACES, INC., a California corporation, as subdivider.

BE IT FURTHER RESOLVED, that a corporate surety bond, No. 730 94 62, issued by THE AMERICAN INSURANCE COMPANY, is hereby accepted as the surety for the required improvements in said subdivision, and that Bond Nos. 146845 and 146846, issued by the ARGONAUT INSURANCE COMPANY, are hereby released.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by June 1, 1981, as provided by the amendment to the subdivision agreement.
