

RESOLUTION OF INTENTION NO. 223866 (R. 79-2248)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE PORTIONS OF THE ALLEY IN GUION'S ADDITION, BLOCK 263, MAP 220; ARLINGTON, BLOCK B, MAP 1638; AND BERGIN'S ADDITION, BLOCK 624, MAP 474, UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and in connection therewith require the reservation of certain easements for portions of the alley in Guion's Addition, Block 263, Map 220; Arlington, Block B, Map 1638; and Bergin's Addition, Block 624, Map 474, in the area covered by such right-of-way.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of portions of the alley in Guion's Addition, Block 263, Map 220; Arlington, Block B, Map 1638; and Bergin's Addition, Block 624, Map 474, as more particularly shown on Drawing No. 13827-B on file in the office of the City Clerk as Document No. 766706.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 P.M. ~~AUG 6 1979~~ in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.


