BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Metropolitan Transit Development Board for engineering design and contract administration associated with the construction of the Cottonwood Pedestrian Walkway (CIP No. 52-253), under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. '766757.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$50,000 for the City's share of the costs for design, construction and contract administration is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$6,000 from Capital Outlay Funds (CIP 52-253) and \$49,500 from Gas Tax Funds (CIP 52-253) is hereby authorized, solely and exclusively for the above purpose and related costs.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
