


RESOLUTION No. 223896 (R-79-2574)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of FREEMAN EQUIPMENT, INC., is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase of SEVENTEEN (17) REFUSE TRUCKS (Mack Cab & Chassis W/Leach Refuse Bodies) for a cost of \$55,447.00 each; for a total cost of \$942,599.00; terms net 30 days, plus sales tax, for a total cost of \$999,154.94.
2. That all bids for HIGH DENSITY EQUIPMENT, (Item 2, Base Bid; Item 4, Alternate A; Item 6, Alternate B) are hereby rejected.
