

A RESOLUTION ACQUIRING OPEN SPACE LAND FOR THE **JUL 2 1979**
SAN DIEGO OPEN SPACE PARK FACILITIES DISTRICT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Council, for and on behalf of the San Diego Open Space Park Facilities District No. 1, hereby declares its intention to hold a hearing to determine whether or not the District should acquire certain property owned by CHILCOTE, INC., and comprising approximately 68.79 acres known as Del Cerro Shores Subdivision Unit #2 in the Lake Murray-Cowles-Fortuna Regional Park, which property is more particularly described as a portion of Lot 67, Rancho Mission of San Diego, and as more particularly shown on Document No. 766679 on file in the office of the City Clerk.

2. That no property improvements to said property are presently proposed.

3. That on JUL 17 1979, 1979, at the hour of 2:00 p.m. in the Council Chambers, Charles C. Dail Concourse, 202 "C" Street, San Diego, California, the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.

4. That the owner or owners of said property may appear at the hearing and be heard orally or by writing signed by them and present evidence for or against the acquisition of said property by the District.
