

RESOLUTION OF INTENTION NO. 223899 (R.79-2566)

A RESOLUTION ACQUIRING OPEN SPACE LAND FOR THE
SAN DIEGO OPEN SPACE PARK FACILITIES DISTRICT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Council, for and on behalf of the San Diego Open Space Park Facilities District No. 1, hereby declares its intention to hold a hearing to determine whether or not the District should acquire certain property owned by WILLIAM A. CORN and HELENE M. CORN (aka HELEN M. CORN), husband and wife as community property, and MARK USELTON, et al., and comprising approximately 17.39 acres known as Bay View in the Chollas-Radio Canyon Open Space System, which property is more particularly described as Parcels #548-060-1; 543-241-22; and 542-650-16 through 23, and as more particularly shown on Document No. 766680 on file in the office of the City Clerk.

2. That no property improvements to said property are presently proposed.

3. That on JUL 17 1979, 1979, at the hour of 2:00 p.m. in the Council Chambers, Charles C. Dail Concourse, 202 "C" Street, San Diego, California, the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.


4. That the owner or owners of said property may appear at the hearing and be heard orally or by writing signed by them and present evidence for or against the acquisition of said property by the District.

That a copy of this resolution shall be posted on the bulletin board of the City Administration Building and be published in a newspaper of general circulation, printed and published in the City once a week for two weeks, the posting and first publication to be on or before the 10th day prior to the day of hearing.
