

**RESOLUTION No.** 223903 (R79-2680 )

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with SAN DIEGO URBAN LEAGUE, INC., for the purpose of continuing the Business Outreach Project under the Public Service section of the CDBG regulations for a four month period from July 1, 1979 through October 31, 1979, and revise the scope of services to require that 100% of the businesses served by the Project during the extended four month period, and not less than 51% of the businesses served by the Project during the entire 15 month contract period shall be owned by residents of or located within the CDBG target areas.

BE IT FURTHER RESOLVED, that the expenditure of not more than \$99,840 in CDBG funds to operate the Business Outreach Project for the additional four month period (\$99,655 from unallocated calendar year 1978 CDBG funds and \$185 from fiscal year 1979 Business Outreach Project savings) be hereby authorized, solely and exclusively, for the above stated purpose.
