

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. 767717, quitclaiming to DEGEN-HALL DEVELOPMENT COMPANY, a California corporation, all the City's right, title and interest in the drainage easement, as more particularly described in said quitclaim deed.
