

RESOLUTION NO. 223931

(R. 79-2588)

WHEREAS, the Council of The City of San Diego, at its meeting of March 27, 1979, adopted Resolution No. 223174 confirming and approving the Street Superintendent's Assessment, Roll No. 3913, covering the cost and expenses of certain public improvements made under the provisions of the Improvement Act of 1911, to wit: the Soledad Mountain Water Pumping Plant; and

WHEREAS, Section 5450 of the Streets and Highways Code and Resolution of Intention No. 217094 adopted by the City Council provide that the City Council shall, upon written request of the contractor or his assigns, direct that assessments of less than fifty dollars (\$50) levied under the provisions of the Improvement Act of 1911 be collected upon the tax roll upon which general taxes are collected; and

WHEREAS, the assignee of the contractor of the above-mentioned project, Stone and Youngberg, has requested, pursuant to the provisions of Section 5450 of the Streets and Highways Code and Resolution of Intention No. 217094, that certain assessments of an amount less than fifty dollars (\$50) be collected through the tax roll; and


WHEREAS, the City Council pursuant to Charter Section 78 has provided by ordinance for the assessment and collection of taxes to be performed by the County Assessor and County Tax Collector of the County of San Diego; NOW, THEREFORE,
