## LEGAL DESCRIPTION

## EXHIBIT A

A portion of the Northwest Quarter of Lot 13 of Horton's Purchase of the Fx-Mission Lands of San Diego, according to Map thereof No. 283, filed in the Office of the County Recorder of San Diego County on March 9, 1873 more particularly described as follows:

BEGINNING at the Southeast corner of Lot 3 of RIDGE VIEW Unit No. 1, according to Map thereof No. 2816, said point being on the North line of said Lot 13 of Map No. 283; thence South 89<sup>0</sup>33'40" East 3.00 feet along said North line of Lot 13 to a point on the arc of a 37.00 foot radius curve concave Northerly, a radial line through said point bears North 89<sup>0</sup>33'40" West from the center of said curve, said center also being a point on the North line of Lot 13 of Map No. 283; thence southerly and easterly along the arc of said 37.00 foot radius curve 116.24 feet through a central angle of 180<sup>0</sup>00'00" to the intersection with said North line of Lot 13 of Map No. 283; thence North 89<sup>0</sup>33'40" West 74.00 feet along said North line of Lot 13 to the POINT OF BEGINNING.
