1. That the bid of \$122,000.00 by DALEY CORPORATION, a corporation, for THE IMPROVEMENT OF IMPERIAL AVENUE FROM 24TH STREET TO 32ND STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 766116.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$23,105.00 from Public Facilities - San Ysidro (Fund 2940 - 73.51) to Imperial Avenue Commercial (Fund 2940 - 73.71).
3. That the expenditure of \$23,105.00 from Fourth Year Community Development Block Grant Fund 2940 - 73.71, to supplement Resolution No. 223373 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
