Said Council hereby finds that that certain map surveyed by WILLIAM B. BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider DONALD L. BREN COMPANY. a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of PENASOUITOS BLUFFS UNIT NO. 11.
