

RESOLUTION NO. 223994 (R.79-2659).

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, a portion of R.S. 133 (Black Mountain Road) has been relocated by the approval on this date of the dedication of the street system within the subdivision to be known as Penasquitos Bluffs Unit No. 11; and

WHEREAS, those properties adjoining that portion of R.S. 133 to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as Penasquitos Bluffs Unit No. 11; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of R.S. 133 (Black Mountain Road), as more particularly shown on Drawing No. 14377-B on file in the office of the City Clerk as Document No. 766949, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

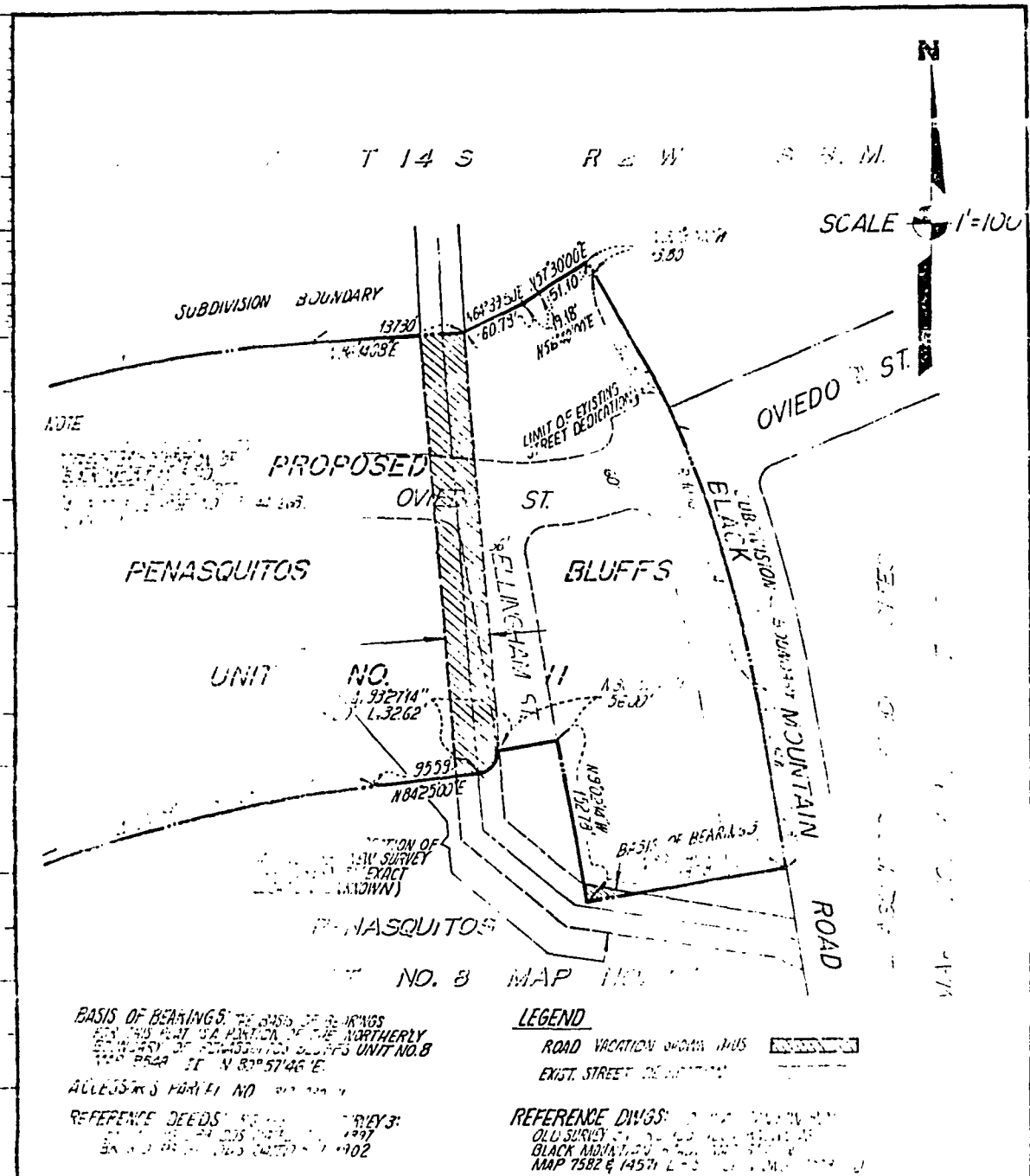
