- 1. That a portion of Talca Avenue, as more particularly shown on Drawing No. 14319-B on file in the office of the City Clerk as Document No. 766948 , which is by this reference incorporated herein and made a part thereof, be and the same is hereby ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
