APPROVING MAP OF WEST PINES

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS F. DEVENING, a Registered Civil Engineer, entitled "WEST PINES Being a subdivision of portions of Lots 1 and 2 of the subdivision of the East Half of Pueblo Lot 1215 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 690, filed in the office of the County Recorder of San Diego County, October 31, 1891.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Stalmer Street and a portion of Angelucci Street for public purposes, and said street and portion of a street are hereby declared to be a public street and portion of a public street and dedicated to the public use.


