
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the installation of a sewer main in PARADISE ROAD, CERVANTES AVENUE AND ARROYO AVENUE from Division Street to 58th Street; ALTA VISTA AVENUE from Cervantes Avenue to 58th Street; and 58TH STREET from Division Street to 500 feet northerly, under the provisions of the Improvement Act of 1911, consisting of 13 sheets and filed under Document No. 766788, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawing, typical cross-sections, profiles and specifications for the installation of a sewer main in PARADISE ROAD, CERVANTES AVENUE AND ARROYO AVENUE from Division Street to 58th Street; ALTA VISTA AVENUE from Cervantes Avenue to 58th Street; and 58TH STREET from Division Street to 500 feet northerly, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvement hereinabove mentioned.
