CONDITIONAL USE PERMIT NO. 548-PC JUL 17 1979

WHEREAS, IMMANUEL BAPTIST CHURCH, a California corporation, Owner, hereafter referred to as "Permittee", filed an application for permission under Conditional Use Permit No. 548-PC, to operate a church school. The property is located on the south side of Red Rock Drive between Scripps Ranch Boulevard and Cummins Place and is more particularly described as Parcel A, Parcel Map No. 2620; and

WHEREAS, on November 16, 1978, the Planning Commission of
The City of San Diego approved Conditional Use Permit No. 548-PC,
subject to conditions, pursuant to Section 101.0506 of the
Municipal Code of The City of San Diego; and

WHEREAS, on May 31, 1979, the Planning Commission of The City of San Diego made its findings of fact, revoked said Conditional Use Permit No. 548-PC and filed said decision in the office of the City Clerk on June 12, 1979; and

WHEREAS, on June 8, 1979, pursuant to the provisions of Section 101.0506 of the San Diego Municipal Code, IMMANUEL BAPTIST CHURCH, by John W. Swearingen, appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on July 17, 1979; and

WHEREAS, the Council of The City of San Diego received for its consideration documentary, written and oral testimony and heard from all interested parties present at the public hearing; NOW, THEREFORE, MCROFILMED

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

All of the following facts exist with respect to Conditional Use Permit No. 548-PC:

- 1. That the City Council hereby revokes Conditional Use Permit No. 548-PC, based on findings that conditions concerning landscaping standards have not been met;
- 2. That the action of the City Council is supported by minutes, documents and testimony received by the City Council, all of which are herein incorporated by reference;
- 3. That the effective date of the revocation shall be forty-five (45) days from the date of the adoption of this resolution and the use of the property for a church school shall cease as of that date. Use of the premises for a church school after the effective date of the revocation of the Conditional Use Permit shall be unlawful.

BE IT FURTHER RESOLVED, that the appeal of IMMANUEL BAPTIST CHURCH, by John W. Swearingen, is denied, and this Council does hereby revoke Conditional Use Permit No. 548-PC.
