WHEREAS, it is now necessary and desirable to amend said Plan to incorporate the provisions of the Internal Revenue Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego Employees' Deferred Compensation Plan, on file in the Office of the City Clerk as Document No. 745636, as amended, be, and the same is hereby further amended to incorporate the appropriate changes and limitations set forth in the Revenue Act of 1978, as contained in the amended Plan on file in the Office of the City Clerk as Document No. 766858.
