BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue a check-warrant in the amount of \$31,850 to TIA JUANA VALLEY COUNTY WATER DISTRICT and RONALD ENDEMAN, its attorney, in full settlement of said parcels of said condemnation.


