William P. Jenkins	General Services	\$ 20	Mr. Jenkins is a Driver I in the Solid Waste Division. He suggested that a safety access area be provide on litter control vehicles. This was considered to be a significant safety improvement.
J. Anthony Dickens	General Services	\$ 15	Mr. Dickens was an Equipment Repair Supervisor at the time of his suggestion. He suggested that walking beam presses be modified to so that they could be used for additional functions. This was considered to be a significant operational improvement.
Bobby J. Magers	Police	\$ 10	Mr. Magers is a Police Officer in the Traffic Bureau. He suggested that vehicle light bars be fixed with identification labels. This was considered to be a significant operational improvement.
Michael A. Gomez	Risk Management	\$ 10	Mr. Gomez is a Claims Representative in the Public Liability Program. He suggested that call back duty be assigned on a rotational basis. This was considered to be a significant operational improvement.
John T. Mulvey	Data Processing	\$ 10	Mr. Mulvey is a Junior Clerk. He suggested that a security lock be installed on a rear access door into the Data Processing area in the basement of the City Administration Building. This was considered to be a significant safety improvement.
